

## PROJECT AGREEMENT

Project Agreement No. 1 to the Forest Development Road Cooperative Agreement entered into on November 24, 1976 by and between the Forest Service, U. S. Department of Agriculture and Salt Lake County, State of Utah.

WHEREAS, both parties are desirous of improving Lambs Canyon Road, Forest Development Road No. 80011, from the Intersection of U. S. Interstate Highway I-80 to the Forest Boundary Section 13, T1S, R2E, and Sections 19, 20, in T1S, R3E, SLB&M, for a distance of 3.5 miles. The work required to bring it up to standard condition to which road was originally constructed for use is described below:

1. Trim back extensive overgrowth
  2. Installation of piping for water and flood control
  3. Asphalt patching
  4. Shoulder & slope repair
  5. Resurfacing of road where necessary
-

Based on estimates prepared by Forest Service and Salt Lake County Engineers, the cost of said road improvements work is estimated to be \$5,000.00

THEREFORE, it is mutually agreed that:

A. The Cooperator will:

1. Perform all tasks necessary to bring the road up to satisfactory condition
- 2 Will maintain the roadway during the life of this contract.
3. Will pay 1/2 the cost of the initial reconstruction

B. The Forest Service will:

1. Pay to the Cooperator 1/2 the cost of the initial reconstruction. The Forest Service share will be approximately \$2,500.00.
2. Pay to the Cooperator the sum of \$250.00 per year as its share of the maintenance costs

This agreement may be amended, modified, or supplemented by agreements reached through exchange of correspondence between both parties
