RIGHT OF WAY RESERVATION

KNOW ALL MEN BY THESE PRESENTS, That in accordance with Section 507 of the Federal Land Policy and Management Act of 1976 (90 Stat. 2781, 43 U.S.C. 1767) that the United States of America acting by and through the Bureau of Land Management, U.S. Department of the Interior does hereby issue and reserve to the Bureau of Land Management and its assigns, a right-of-way of access to use the existing road over and across the following described public lands situated in the County of Salt Lake, State of Utah, to wit:

T. 4 S., R. 2 W., SLM
Section 20, NE $\frac{1}{4}$ NE $\frac{1}{4}$, W $\frac{1}{2}$.

The right-of-way width is 50 feet, 25 feet on either side of the center line, and 3458.04 feet long and contains 3.97 acres.

A map showing the right-of-way is attached hereto as exhibit A and made a part hereof.

The right-of-way herein granted and reserved is for the full use of the access road by the Bureau of Land Management, its licensees, permittees, agents and contractors including the right of access to the people of the United States generally to lands owned, administered, or controlled by the United States of America, subject to reasonable rules and regulations of the Secretary of the Interior. This reservation shall remain in effect in perpetuity commencing on the date shown below until no longer needed for intended purpose of the right-of-way.

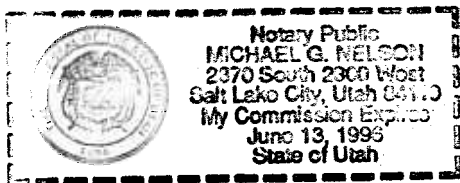

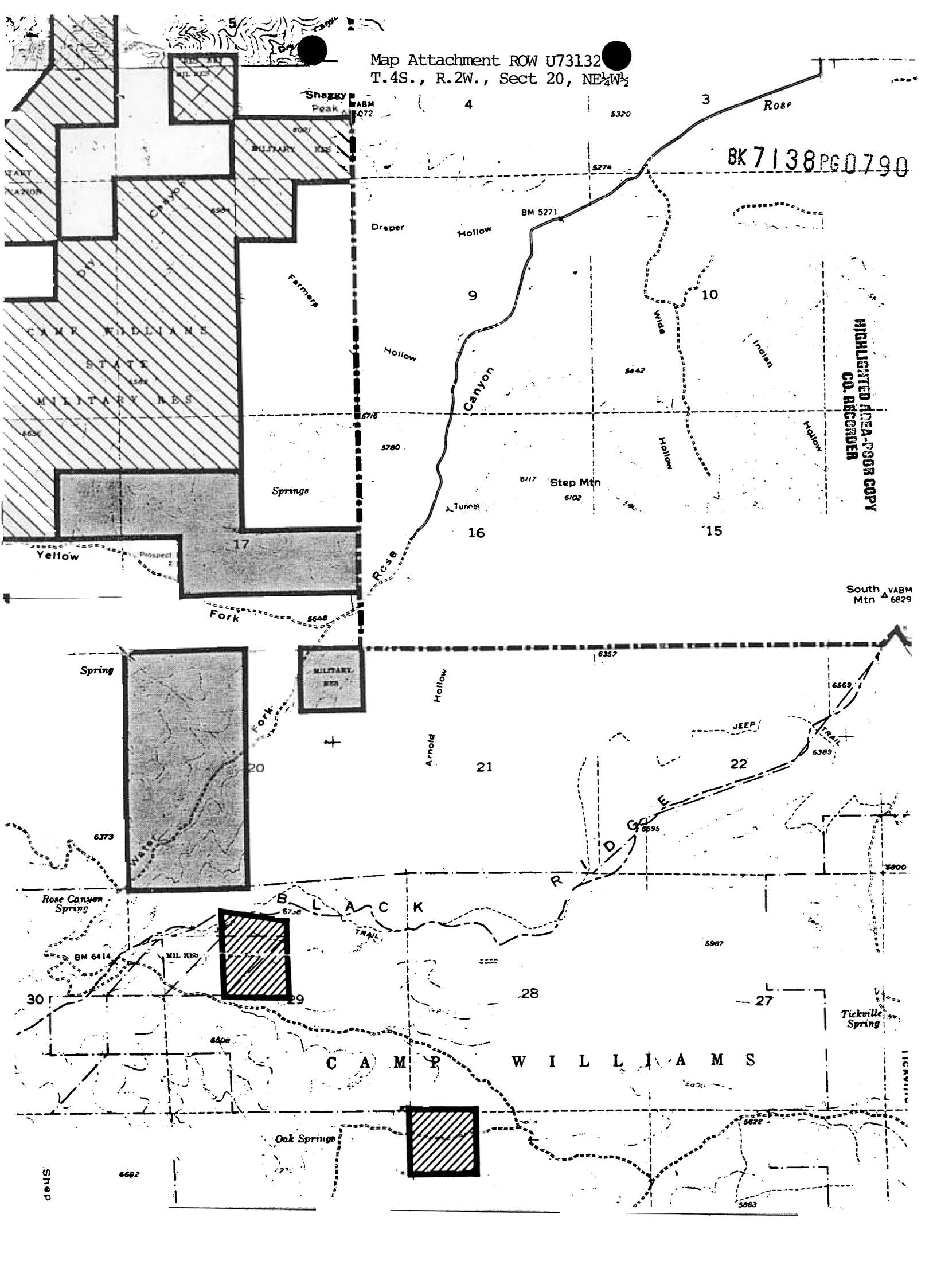
